As an IT company, we actually are a digital contractor. For example, we build web applications (mobile, platforms, UX / UI, ...) that we can design and host ourselves. We usually do custom work and really focus on the business of our customers. We like to build platforms together with our customers where we have an impact on their business and always start from a professional analysis of the existing situation.

The digital tool would most likely be an application which is browser-built and accessible from each possible device. At the start of the project 30% of the total will be invoiced. After 2 months another 40% is invoiced. Upon delivery the remainder is billed. After analysis the final scope of the project is fixed.

Work required for scope changes which emerge during project life-time will first be estimated and only scheduled after approval. All work performed as a result of these scope changes is billed at the end of the month (time & material) at a daily rate of 750 EUR (on top of the agreed upon project price).

For this model, we were thinking of a SAAS model of 500 euro per month per customer.


